Why study this program?

The lectures on law and economics under this E-Certificate course will explore and introduce the nature of law and economics or economic analysis of law to the aspiring institute students and researchers to have an intellectually inclined perspective to explore this branch of research and learning in law. The methodology of economic analysis of law is not similar to the traditional analysis of the legal problem or as legal analysis is conducted to solve the legal problem. Interested participants can explore applications methodology and modelling (involving econometrics/ machine learning models) based on the learning in the class.
