- 2. Content: Arial style, font size 11 with 1.5 line spacing, Headings and subheadings in bold
- 3. Footnotes (preferably with hyperlink): Arial style, font size 10 with 1.0 line spacing, OSCOLA citation style (latest edition)
- 4. All submissions must contain a cover page including title of the article, a short bio of the author (including name, educational qualifications, institutional affiliation and areas of interests) and a professional photograph.
- 5. All submission must be made in doc or docx format only.
- 6. Word Limit: 750-1000.

- 7. Kindly refrain from any act amounting to plagiarism.
- 8. Category of Articles you can submit:
  - a) Opinion pieces but well researched and responsibly authored opinions
  - b) Journal styled articles
  - c) Case Comment (preferably of a recent case- India or Foreign)
  - d) Comment on any State policy/new bill/new statute/law commission report or report of any government department.
  - e) Book reviews
