It helps to dissect the issue in multiple dimensions in order to bring out the novel findings or to conduct doctrinal or empirical research and many more...

With this, I feel elated to share that today I have completed my Day01- Workshop on "Legal research and Writing" conducted by Dr. Nachiketa Mittal Sir. The two-hour intense reading workshop helped me to dive deeper into the practical aspect of researching and introduced me with the key elements involved in the process.

I wish to list down few of my learnings from today's workshop:

- 1. Legal research is something which requires patience in reading, wherein during the process you silently communicate with the author and try to understand the author's point of view of writing the article.
- 2. It is the process wherein you critically analyze the issue in question, and try to come up with your own basic understanding, which may include supporting or digressing from author's point of view.
- 3. The process involves sitting of at least few hours continuously in order to assimilate the thoughts of the author and critically analyze the issue and come-up with your own genuine conclusion.

I would like to share the key takeaways from the workshop-

- Always try to substantiate and back your arguments with authentic sources.
- Collecting and analysing data during research helps us bring new perspectives and enhance the overall quality of research.
- 3. Always try to formulate your thoughts well before writing. Literature review is important but don't copy the writing style of another author.
- A good research article requires patience, time and undivided attention.
- Reading the existing literature on the topic is like a silent communication with the authors. Do analyze and cross question each argument to enhance your learning curve.
- Good writing requires better reading. Try to read and analyse the writing style and sentence structuring of the authors.
